# FIRST AMENDMENT TO THE BYLAWS OF SABLE CREEK OWNERS ASSOCIATION, INC. [Quorum]

THIS FIRST AMENDMENT TO THE BYLAWS OF SABLE CREEK OWNERS ASSOCIATION, INC. (this "First Amendment") is made to be effective as of the 29th day of January , 2024, by Sable Creek Owners Association, Inc. (the "Association").

### **WITNESSETH:**

WHEREAS, Sable Creek Partners, Ltd. ("Declarant") recorded the Declaration of Covenants, Conditions & Restrictions for Sable Creek on or about May 31, 2005, as Instrument No. 2005-63522 of the Real Property Records of Denton County, Texas (the "Declaration"); and

WHEREAS, the initial Board of Directors adopted the Bylaws of Sable Creek Owners Association, Inc. (the "Bylaws"); and

WHEREAS, Article 18, Section 18.01 of the Bylaws provides that, after the Declarant Control Period, the Bylaws may be amended, altered or repealed at a regular or special meeting of the Members of the Association by the affirmative vote in person or by proxy of Members representing a majority of a quorum of the Association; and

WHEREAS, the Declarant Control Period has ended pursuant to Article 1, Section 1.02 of the Bylaws; and

WHEREAS, pursuant to the authority granted in Article 18, Section 18.01 of the Bylaws, the following amendment to the Bylaws was approved by the affirmative vote in person or by proxy of Members representing more than a majority of a quorum of the Association at a meeting of the Members of the Association held on January 31.

NOW, THEREFORE, the Bylaws are amended as follows:

1. Article 5, Section 5.03 of the Bylaws is deleted in its entirety and replaced with the following:

### Quorum

5.03 The presence, either in person or by proxy, at any meeting, of Members entitled to cast at least ten percent (10%) of the total voting power of the Association shall constitute a quorum for any action, except as otherwise provided in the Articles or Declaration. In the absence of a quorum at a meeting of Members, a majority of those Members present in person or by proxy may adjourn the meeting

to a time not less than five (5) days nor more than thirty (30) days from the meeting date.

- 2. In the event of a conflict between this First Amendment and any other provision of the Bylaws, this First Amendment shall control.
- 3. Except as modified by this First Amendment, the Bylaws shall remain in full force and effect.


